- 1. Payment of the rental, including any deposit, constitutes the Guest's/Client's/Tenant's acceptance of these Terms and Conditions.
- 2. Cancelation policy.
 - Guests who cancel at least 14 days before check-in will get back 100% of the amount that they've paid. If they cancel between 7 and 14 days before check-in, they'll get back 50%.
 Otherwise, you won't get a refund.
 - COVID-19 cancelation due to Government Health Order
 Unfortunately, we can no-longer absorb the cost of COVID-19 related cancellations and bookings are subject to a \$80 COVID-19 cancellation fee. If you made your booking through the Vrbo/HomeAway/Stayz website, any service fee(s) you paid to Vrbo/HomeAway/Stayz is not refundable.
